**Post :** Sr. Resident Officer

**Place of Posting:** New Delhi

**Vacancy:** 01

#### **Eligibility:**

- A. Essential:**(a) First Class Masters/Bachelor's in Engineering or equivalent from recognized university, and
- (b) Have More than 15 years working experience in the Executive Officer grade of scale Rs. 8000-275-13500 (pre revised) including Pay Band 15600-39100, Grade Pay 5400/-.
- (c) Have worked in the equivalent scale of Rs. 9000-14400 (pre revised) including Pay Band 15600-39100, Grade Pay 6000/- or higher for more than two years continuously.
- B. Desirable:**(a) Have worked/having overall view of all functions of power sector viz. distribution, transmission, generation, regulatory affairs, renewable energy sources, etc.
- (b) Having experience of Liaison and Public Relation with Central/State Government Departments
- (c) Acquainted with Central Government Department and other Power Sector Organizations.

**Age:** Not more than 45 years as on 31.03.2010.

**Pay Scale:** On appointment to the post of Sr. Resident officer the pay of the Officer shall be fixed in the scale of Rs. 15600-39100 + Grade pay Rs. 7200 at the stage equal to the pay notionally arrived at by increasing the actual pay drawn by him in the existing post (in substantive or Officiating capacity) by Rs. 300/- and in case there is no such equal stage then on the next higher stage.

**Tenure:** The post of Sr. Resident Officer shall be filled in by an Officer for a tenure ordinarily not exceeding three years which may be extended by the Board for further period of 3 years but not more than one year at a time.

**Pension & Provident Fund :** If the person concerned retires while holding the post of Sr. Resident Officer his emoluments for the purpose of calculating pension gratuity under Employee Service Regulations of the Nigam, shall be taken at what he would have been entitled to have, had he not been appointed as Sr Resident Officer.

**Note :** No candidate who has more than two children on or after 1.6.02 shall be eligible for appointment to the service, but the candidate having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he/she has on 1.06.2002 does not increase.

The other terms & conditions for appointment to the post of Senior Resident Officer, New Delhi shall be applicable as laid down in Rajasthan Rajya Vidyut Prasaran Nigam Limited (Special Selection Rules for filling up the post of Sr. Resident Officer, New Delhi) Rules.
