NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 20 of the Rajasthan Value Added Tax Act, 2003 (Act No.4 of 2003), read with sub-rule (2) of rule 40 of the Rajasthan Value Added Tax Rules, 2006, the State Government hereby makes the following amendment in this department's notification No. F.12 (63)FD/Tax/2005-81 dated 11-08-2006, as amended from time to time, namely:-


AMENDMENT

In the said notification, after the existing last proviso, the following new proviso shall be added, namely:-

"Provided also that in case of a turnkey works contract awarded by a Department of any Government, a corporation, a public undertaking, a cooperative society, a local body, a statutory body, an autonomous body, a trust, a private limited company or public limited company, having a separate contract for supply of goods, and in pursuance of such contract, the contractor claims that the sale of goods has occasioned in the course of inter State trade and commerce by the contractor to the awardee from outside the State, the Assessing Authority or an officer authorized by the Commissioner in this behalf on an application submitted by the said contractor, shall within ten days of receipt of such application, on being satisfied that the transaction of sale took place in the course of inter State trade and commerce, pass an order directing the awardee not to deduct the amount in lieu of tax from the payment to be made in this behalf. The order so issued shall be provisional in nature and applicable only for deduction of amount in lieu of tax under sub-section (2) of section 20 of the Rajasthan Value Added Tax Act, 2003, and shall be subject to assessment under the said Act."


