**Notice Inviting Bids for purchase of 200 MW Round the Clock (RTC) power for
Short Term (15.04.2009 to 15.05.2009) from various trading
licensees/generators/state utilities/CPPs/Distribution licensees/SEBs.**

Jaipur Vidyut Vitran Nigam Ltd. (JVVNL), Ajmer Vidyut Vitran Nigam Ltd. (AVVNL), Jodhpur Vidyut Vitran Nigam Ltd. (JdVVNL) are Government of Rajasthan undertakings, incorporated under the Companies Act, 1956 and have been formed with an objective to carry on the business of distribution and supply of electricity in the area of supply mentioned in its license.

RAJASTHAN POWER PROCUREMENT CENTRE (RPPC) as a Nodal Agency is inviting sealed bids on behalf of JVVNL, AVVNL and JdVVNL for purchase of power from various trading licensees/generators/state utilities/CPPs/Distribution licensees/SEBs.

RPPC wishes to invite offers from the eligible bidders for purchase of 200 MW Round the Clock (RTC) power on firm basis for short term (one month) commencing from 15.04.2009 or any later date as may be decided by Rajasthan Discoms.

The bidders are allowed to offer minimum 10 MW power on firm basis. Any offer of power below 10 MW shall be rejected. Bid Document may be collected from CE (RPPC) office in the office timing i.e. 9.30AM to 6 PM.

The bidders may download bid document from our web sites, www.rajenergy.com & www.tenders.gov.in

The Bid may be submitted in the CE (RPPC) office on or before 13.04.2009 by 11:00 hours and the same will be opened on the same day at 11.30 hours. The offers received after 11.00 hrs of 13.04.2009 shall not be accepted. The representatives of the participating parties may be present at the time of opening of the bid, if they so desire.

The Bid submitted by the Bidder and all correspondence and documents relating to the bid shall be written in the English Language.

The Bidder shall have to deposit earnest money of Rs 10,00,000/- (Rs. Ten lac only) in the form of Crossed demand Draft of any nationalized Bank/Scheduled bank drawn in favour of Accounts Officer (CPC), JVVNL, Jaipur payable at Jaipur as a security deposit (EMD).

RPPC reserves the right to reject any or all bids or to accept any bid in full or part at its sole discretion without assigning any reasons whatsoever thereof. No correspondence in this regard shall be entertained by RPPC/Discoms.
